Further, it is also informed that on scrutiny of the application of extension and documents submitted by school, the following deficiencies have been observed, which need to be complied by school before the periodical inspection of school and documentary evidences to this effect must be produced before the inspection committee at the time of inspection & duly attested copy of compliance be submitted along with Inspection Committee Report:-

1. The school is required to re-constitute the School Managing Committee by nominating Principal as Member Secretary, representatives of 02 teachers, 02 parents & 02 members nominated by the Board. The school is also required to forward 5-6 names of the Principals of the nearby CBSE affiliated school (2-3 of them may be from KVs / JNVs) for approval 02 of them as Board's nominees for inclusion in School Managing Committee.

2. **03 NTTs, 01 TGTs are short** in the school as per norms. Hence, the school is required to appoint more trained and qualified teachers to maintain section-teacher ratio as per norms and furnish a fresh staff statement accordingly.
3. The school is required to maintain **reserve fund** in favour of the Principal of the school and managing trustee/member of the society/trust/company running the school, as per norms and submit proof.
4. The school is required to implement EPF on school name separately instead of society name and submit latest month **EPF challan**.
5. The School is required to submit audited **financial accounts** of the school for the last 03 years.

However regularization of general affiliation from 2019 for a period of 05 years will be subject to the outcome of the inspection report and specific compliance of above deficiencies by the school.
